**Job Opening for Tenure Track Assistant/Associate Professor (For Women Only)**  
**Institute of Economic Research, Kyoto University**

The Institute of Economic Research, Kyoto University, is searching for a tenure track assistant/associate professor (1 person). The position is for a six-year term and is promotable to a tenured position subject to mid-term evaluations conducted before the completion of the third year and final evaluations conducted before completion of the fifth year. With positive evaluations, a promotion may be made at the beginning of the sixth year, and occasionally, a tenure track faculty member with an outstanding research record may be promoted before the fifth year. The standards for selection for this position include: (1) strong research achievements at an international standard, (2) capability to engage in advanced economic research promoted by our Institute, and (3) readiness to engage in joint research activities.

**【Requirements】**

An applicant must hold a Ph.D. (or be expected to acquire a Ph.D. by the beginning of employment) and should be currently engaged in research promoted by our Institute. For Women Only.

An applicant will be required to sign a letter of consent promising to comply with the Kyoto University Code on Terms of Employment for Faculty Members before any final offer is made.

**【Evaluation Process】**

All applicants will be screened in the light of the standards described above. Those who pass screening will be invited to visit our Institute for a research presentation and interviews by our faculty members.

**【Expected Start of Employment】**

April 1, 2024, or later.

**【Probation Period】**

6months.

Institute of Economic Research (Main Building, North Building, General Research Building No.2)

**【Employment Status】**

7 hours and 45 minutes per day, 38 hours 45 minutes per week under a discretionary work system

**【Salary and Benefits】**

The letter of recommendation (4) should be sent by E-mail or mail by the referee directly to the address below. In case of E-mail, the subject line should be "Applicant's name: Letter of Recommendation for Tenure-Track Position (For Women Only) Application". It must be received by the deadline.
