

**Professor Position in the Research Section of Earthquake Resistant Structures,
Disaster Prevention Research Institute, Kyoto University**

The Disaster Prevention Research Institute (DPRI), Kyoto University invites applications for a permanent Professor position.

Location: Research Division of Earthquake Disasters, Seismic and Volcanic Hazards Mitigation Research Group, Disaster Prevention Research Institute, Kyoto University, Gokasho, Uji, Kyoto 611-0011, Japan (at home or other places if University allows or orders to work remotely).

Job description and required qualifications:

The appointed professor will focus on conducting research related to methods to evaluate seismic performance of buildings with high accuracy, by utilizing limit state evaluation of structures through analysis and/or experiments, or evaluation of actual damage conditions based on on-site surveys. Based on these results, technology development for improving building performance will be conducted by developing methods to evaluate the functionality of buildings considering business continuity after earthquakes. Furthermore, promoting collaborative research with domestic and international researchers, leading the integration of science and engineering research for disaster prevention studies, and active involvement in developing and revising standards and guidelines related to buildings in Japan are expected.

The candidate will be responsible for educating students in the Department of Architecture and Architectural Engineering at the Graduate School of Engineering, Kyoto University. A Ph.D. or an equivalent degree is required, and the candidate is expected to teach classes in Japanese.

Anticipated start date: As soon as possible on or after April 1, 2027.

Probation period: 6 months

Working time: Discretionary labor system (standard working hours: 7 hours 45 minutes per day, 38 hours 45 minutes per week). If the discretionary labor system is not chosen the working hours are from 8:30 to 17:15 with a break between 12:00 to 13:00. Overtime may be ordered. Days off: Saturdays, Sundays, Statutory holidays under the Act on National Holidays, Year-end and New Year's holidays, and Anniversary of Foundation of the University.

Salary and Allowance: To be determined in accordance with Kyoto University regulations.

Social insurance: (1) National Public Service Mutual Aid Associations, (2) Employee's pension insurance, (3) Unemployment insurance, and (4) Worker's accident insurance

Applicants should prepare the following materials:

- (1) Curriculum vitae
- (2) List of publications (divided clearly into refereed journal papers and others)
- (3) Copies of up to five relevant papers
- (4) Brief summary of research and related contributions (up to four A4 pages)
- (5) Statement of research plans (up to four A4 pages, including figures)
- (6) Recommendation letters from two references (a recommendation letter may be substituted by the name and contact information of a reference, including the postal address, and e-mail address)
