Measures in Response to the Novel Coronavirus (COVID-19) (Ver. 3)

1. Kyoto University's Policy on the Novel Coronavirus

Kyoto University is taking measures to prevent the spread of the novel coronavirus in accordance with the Kyoto University Policy on the Novel Coronavirus. Regarding the implementation of classes, the first semester will commence from May 7 (Thu.), as announced in the notice "Changes to the class schedule for 2020" on the KULASIS student portal. In certain cases, if deemed necessary, the classes for some specialized undergraduate and graduate courses may commence before May 7 (Thursday). In such cases, details will be provided by the relevant faculties or graduate schools. Please note that further delays in the commencement of classes is possible depending of future developments in the novel coronavirus outbreak.

3. After traveling (or returning) to Japan from overseas

O Both Japanese and foreign nationals traveling to Japan from overseas are subject to a two-week period of self-quarantine at a location designated by the Quarantine Office (such as their own home), and are instructed not to use public transport during the two-week period (they must travel in their own car or in a vehicle rented at the airport). If they cannot arrange such transportation, they must stay at a hotel near the airport for the duration of the two-week self-quarantine. Please be sure to book a hotel for two-week quarantine period before leaving your home country.

O In accordance with the university's policy, we are instructing students traveling (or returning) from overseas to stay at home (studying at home, etc.) for two weeks while monitoring their health carefully, unless they must go outside for unavoidable reasons.

O The university will take appropriate measures to ensure that students who are self-quarantining to monitor their health for two weeks after returning or travelling to Japan from overseas are not disadvantaged (such as extended deadlines for course registration, the provision of supplemental classes, and report assignments, etc.).
