**Notice: Special permission for re-entry to Japan under the coronavirus restrictions**

Please consult with the Immigration Bureau of Japan directly to discuss whether a particular case will qualify as special or exceptional circumstances for the granting of re-entry permission.

2. **Applications for the re-issue of a certificate of eligibility due the applicant's period of stay expiring while they were abroad and waiting to re-enter Japan.**

If a foreign national temporarily leaves Japan with re-entry permission or special re-entry permission, but, due to restrictions caused by the novel coronavirus, they are unable to return before the re-entry permission expires, it is necessary for them to apply for a new certificate of eligibility in order to obtain a new visa to enter Japan. In this case, the Immigration Bureau of Japan requires a statement of the reasons for the re-application for the certificate of eligibility.

The statement must be written in Japanese using the official form (please refer to the next page).

Host professors or university administrative staff may request the International Service Office to make an application for a certificate of eligibility by proxy. In this case, the faculty or staff member making the request should prepare the statement of reasons and send it to the International Service Office via the university's internal mail service.
